**OFFICE MEMORANDUM**

**Sub: Monitoring of price movement of notified medical devices as 'Drugs' under the Drugs and Cosmetics Act, 1940 and the Drugs and Cosmetics Rules, 1945**

The undersigned is directed to refer to this office OM of even number dated 12<sup>th</sup> May, 2017 on the above subject by which all the Medical Device Associations and manufacturers/ importers /marketers were requested to submit by May 31,2017 data as per the format enclosed along with the OM in respect of 19 medical devices irrespective of their classification. However, it has been observed from the data received in NPPA so far that few manufacturers/ importers /marketers of 19 specified devices have not yet submitted the data. Authority has taken a serious note of non-compliance by such companies. This issue has been considered and it has been decided to extent the last date of submission of data by seven working days from today i.e., **upto 9<sup>th</sup> June, 2017** as a last opportunity.

2. All Medical Device Associations and Manufacturers/importers /marketers are hereby requested to submit the data as per the prescribed format in respect of all the 19 medical devices irrespective of their classification. The hard copy should be duly signed by the authorized representative of the companies with office seal giving details about the name of the person, designation, mobile number and email id. Copies of the license issued by Drug Controller General of India for each medical device must be attached along with the data. A soft copy of the data (both in PDF format and excel format) and license be also sent through email to [nihalpedric@nic.in](mailto:nihalpedric@nic.in).

3. Failure to submit the data by the defaulting companies within the extended time will be considered very seriously and NPPA shall be constrained to invoke its power under paragraph, 29 & 30 of Drugs (Prices Control) Order 2013 to conduct inspection at the premises of the defaulting companies to collect such information.
