DEMAND NOTICE

Sub: **Implementation of Coronary Stents prices fixed and notified under the provisions of DPCO,2013: - Overpricing of Coronary Stents – regarding.**

Sir,

I am directed to refer to this Office letter No.20(8)/2017/Div.III/NPPA(Pt), dated 21st March, 2017 and your letter dated 31/03/2017 forwarding various documents in response to NPPA's letter under reference. All the documents submitted by you have been examined in this office.

2. It is reiterated that as per para 5 of the OM dated 21st February, 2017, for the implementation of a price cap, the effective date is the date of billing and not the date of angioplasty. If a patient has angioplasty done before 14th February, 2017 and billed on 14th February, 2017 or after, the patient will mandatorily get the benefit of the revised prices.

3. As in the case of Shri Bhajan Singh, the final bill was issued to him on 15th February, 2017 in which he was charged ₹60,000 for Endeavour Sprint stent. In case of Shri Prem Chand, the final bill was raised on 14th February, 2017 and he was billed for the drug coated xpedition ₹1,25,000. (copies of the bills are enclosed). It may be seen that both the patients have been overcharged which is in violation of the ceiling prices fixed for coronary stents by Government vide Notification S.O 412 (E), dated 13/02/2017.

4. Therefore, the hospital is liable to deposit Rs.1,26,547(Rupees one lakh twenty six thousand five hundred forty seven only) being overcharged amount which includes interest @15% pa under the provisions of DPCO, 2013 by way of demand draft in favour of **“The Pay and Accounts Officer (NPPA), Department of Pharmaceuticals, Ministry of Chemicals & Fertilizers, New Delhi within 30 days from the date of issue of this letter.** The calculation sheet is attached for reference.

5. It may also be noted that the amount indicated above is provisional and is without prejudice to any further amount that may be raised by this officer under the provision of DPCO, 2013 based on further information. The DPCO, 2013 has been issued by the Central Government in exercise of the powers conferred by Section 3 of the Essential Commodities Act, 1955 and any contravention of the provision of the DPCO, 2013 is punishable in accordance with the provisions of the Essential Commodities Act, 1955.
